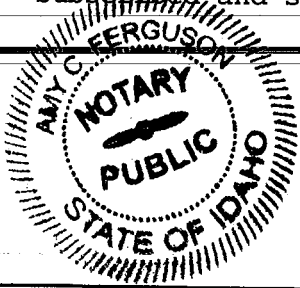
Declaration of Candidacy

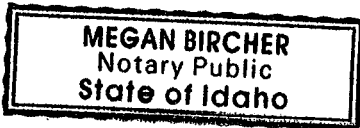

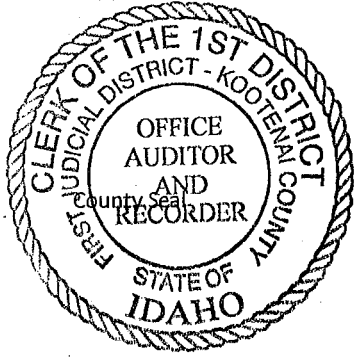
