CALL TO ORDER: The meeting was called to order by Mayor Bloem.

INVOCATION was led by Pastor Joe Donaldson, Bethel Baptist Church.

PLEDGE OF ALLEGIANCE: Councilman Copstead led the pledge of allegiance.

PRESENTATION – **LEGAL DEPARTMENT ANNUAL REPORT:** City Attorney, Mike Gridley, introduced the staff and their roles in the City's Legal Department. He reviewed the activities of the department for the past year including working on such projects as Hillside regulations, Adelphia Franchise renewal, Educational Corridor as well as processing approximately 100 cases per week.

PRESENTATION – PRELIMINARY BUDGET FY 2003-2004: City Treasurer/ Finance Director, Troy Tymesen, presented the preliminary budget. He noted that by adopting the Resolution, the Council would be setting the maximum amount for the budget as well as setting the public hearing for September 2, 2003.

PRESENTATION – LOCAL LAW ENFORCEMENT BLOCK GRANT: Police Captain Wendy Carpenter outlined the items being requested by the Police Department as part of the Local Law Enforcement Block Grant of \$41,028 with a match of \$3,730. Some of the items that this grant will be used for are a Keyfile records storage system, patrol vehicle light bar replacement, digital cameras for patrol vehicles, Stinger flashlights with chargers and batteries, 75 traffic cones, and polygraph system that will be shared with the Sheriff's Department, Post Falls Police Department, and community relations materials and handouts.

PUBLIC COMMENTS: Mayor Bloem asked for public comments with none being received.

PUBLIC HEARING – V-03-5 – VACATION OF PORTION OF ROAD ON NORTH IDAHO COLLEGE PROPERTY: Mayor Bloem announced the rules of order for this public hearing. Chris Bates, Project Manager, gave the staff report.

Mr. Bates reported that North Idaho College is requesting the vacation of a portion of undeveloped road from the Fort Sherman Abandoned Military Reservation, lying westerly of College Drive and south of River Avenue on the site of the proposed Health Sciences Building and parking lot. He noted that this is an undeveloped strip of ground that was previously in the baseball field and now under a parking lot. This is a remainder portion that was created after the previous vacation in 1976. By vacating the road, it would allow the college to construct their proposed classroom and parking lot.

A total of 1 notice was mailed with 0 responses being received.

PUBLIC COMMENTS: Mayor Bloem called for public comments with none being received.

Motion by Wolfinger, seconded by Edinger to approve the vacation of roadway at North Idaho College. ROLL CALL: McEvers, Aye; Reid, Aye; Goodlander, Aye; Edinger, Aye; Wolfinger, Aye; Copstead, Aye. Motion carried.

PUBLIC HEARING – ZC-4-03 – ZONE CHANGE AT 1409 GOV'T WAY: Mayor Bloem read the rules of order for this public hearing. No conflict of interest was declared by any Council member. John Stamsos, Associate Planner, gave the staff report.

Mr. Stamsos gave the applicant's name as Nancy Powers, the location as 1409 Government Way and the reason for the request as a zone change from R-12 to C17L.

He went on to give the staff analyses for land use/neighborhood characteristics, zoning, and utilities. On July 8, 2003, the Planning Commission recommended approval of the zone change.

Mr. Stamsos reported that 34 notices of this public hearing were mailed on August 1, 2003 with 1 response in opposition being received. Written comments were distributed for Council review.

PUBLIC COMMENTS: Nancy Powers, 1423 N. Government Way, applicant, requested Council approve the requested zone change.

Motion by Copstead, seconded by Wolfinger to approve the zone change and to adopt the Findings and Order of the Planning Commission. ROLL CALL: Copstead, Aye; Edinger, Aye; Goodlander, Aye; McEvers, Aye; Reid, Aye; Wolfinger, Aye. Motion carried.

PUBLIC HEARING –A-5-03 – ANNEXATION AND ZONING OF 11-ACRE PARCEL AT THE SOUTHWEST CORNER OF ATLAS AND APPALOOSA:

Mayor Bloem read the rules of order for this public hearing. John Stamsos, Project Manager, gave the staff report.

Mr. Stamsos gave the applicant's name as John Brewster, the location as an 11-acre parcel located as the southwest corner of Appaloosa and Atlas Road and the reason for the request as annexation of the property with an R-8 zoning.

Mr. Stamsos gave the staff analyses for land use/neighborhood characteristics, Comprehensive Plan, and utilities. On May 27, 2003 the Planning Commission recommended denial without prejudice for the zoning of this property at R-8.

He reported that a total of 54 notices for this public hearing were mailed to the property owners within 300 feet of the subject property. Total responses received from residents within 300 feet were 9-0 in favor, 7 opposed and 2 neutral. The City also received a total of 95 responses from residents outside the 300-foot radius all in opposition to this annexation and proposed zoning. A petition with 115 names, many of which sent in the letters of opposition, was received. John Stamsos read the wording of the petition into the record.

PUBLIC COMMENTS: Stuart Smith, 4108 Appaloosa, spoke in opposition to the proposed annexation and zoning. John Brewster, 4071 2nd Street, Yorba Linda, CA, applicant for the annexation and zoning, requested Council approval of his request. Cecil Thorpe, 4010 Appaloosa Rd, spoke in opposition to the proposed annexation and zoning. Russ Helgeson, 2642 E. Cherry Hill Road, engineer for John Brewster, noted that the proposed zoning is to match the existing zoning to the property to the north which is also owned by Mr. Brewster. He also noted that the proposed plat shows the lots average 3.5 lots per acre with the average lot size at 9,300 square feet. Carl Benson, 3701 Lodgepole, who spoke in opposition to the requested annexation and zoning, asked if the applicant currently owns the subject property, the applicant responded that he will own it if the annexation and zoning are approved. Karen White, 3016 Lodgepole Road, spoke in opposition to the requested annexation and zoning and questioned how the plat could be

approved by the Planning Commission prior to the Council hearing the request for annexation of property. Charlie Bean, 3304 Lodgepole, spoke in opposition to the requested annexation and zoning noting traffic concerns. Carol Griffin, 3604 Sherwood Drive, spoke in opposition. Ed Wroe, attorney for the applicant, noted that the field will eventually be developed, and asked Council whether it should be zoned an R-8 zoning. Tom Keopple, 3815 Appaloosa Rd., spoke in opposition to the request. Rob Lunceford, 3355 N. Old Atlas Road, whose mother currently owns the property, noted that his mother does stand behind her letter of support of the annexation and zoning.

Motion by Edinger, seconded by Wolfinger to deny without prejudice the request for annexation and zoning and adopt the Findings of the Planning Commission. Councilman Edinger called for question, which failed by a voice vote of the Council. ROLL CALL: Copstead, No; Edinger, Aye; Goodlander, Aye; McEvers, No; Reid, No; Wolfinger, Aye. Motion failed with the Mayor voting in the negative.

Motion by Copstead, seconded by Reid to approve the annexation and R-8 zoning. ROLL CALL: Copstead, Aye; Edinger, No; Goodlander, No; McEvers Aye; Reid, Aye; Wolfinger, No. Motion carried with the Mayor voting in the affirmative.

Motion by Copstead, seconded by Reid to adopt the Findings and Order as presented. ROLL CALL: Copstead, Aye; Edinger, No; Goodlander, No; McEvers, Aye; Reid, Aye; Wolfinger, No. Motion carried with the mayor voting in the affirmative.

RECESS: Motion by Wolfinger, seconded by Edinger to take a 5 minutes recess. Motion carried. The meeting recessed at 8:50 p.m. The meeting reconvened at 9:03 p.m.

PUBLIC HEARING – APPROVAL OF COSTS FOR DEMOLITION OF BUILDING AT 513 S. 19TH: Mayor Bloem read the rules of order for this public hearing. Gordon Dobler, Growth Services Director, gave the staff report.

Mr. Dobler reported that the owner of the property is Melvin McAnulty, et al, and the work completed at 513 S. 19th Street consisted of an appraisal, removal of asbestos, demolition of two buildings, cleanup, and materials disposal and leveling of the lot. The total costs associated with this demolition were \$3,060.00.

PUBLIC COMMENTS: Mayor Bloem called for public comments with none being received.

Motion by Wolfinger, seconded by Copstead to approve the costs for the demolition of buildings at 513 S. 19th Street and direct staff to place a lien on the property to cover the costs incurred. ROLL CALL: McEvers, Aye; Reid, Aye; Goodlander, Aye; Edinger, Aye; Wolfinger, Aye; Copstead, Aye. Motion carried.

U.S. SPEAKER OF THE HOUSE VISITS COEUR D'ALENE: Councilman Wolfinger announced that he has spent the past few days with U.S. Speaker of the House Hasker who commented on how beautiful the area was and how friendly the people are in this area.

RECREATION DEPARTMENT ACTIVITY REPORT: Councilman Copstead announced that the Recreation Department is registering for 3rd, 4th, and 5th grade flag football. They are also currently registering for youth swim lessons and karate classes ages 5 and up, and adult co-ed soccer league. The Washington Department of Transportation will be holding their annual softball tournament in Coeur d'Alene this month. He expressed his appreciation for the 50 volunteers who help plant 50 trees at the Shadduck Park. A special thanks goes to electrical contractor Scott Jordan, owner of Interstate Electrical for donating the electrical wiring at Shadduck Park. The cost for wiring was approximately \$2,000. He distributed a copy of the photo album of the 2002-2003 Summer Camp for our Special Needs Program.

LIBRARY FOUNDATION FAIR BOOTH: Councilman Goodlander announced that the Library Foundation will have a booth at this year's North Idaho Fair. The Foundation will have some authors at their booth and encouraged residents to stop while they are at the Fair.

APPOINTMENTS – SIGN BOARD AND ARTS COMMISSION: Motion by Wolfinger, seconded by Edinger to approve the appointments of Mike Patano and Sharon Southerland to the Arts Commission, the re-appointment of Doug McQueen to the Sign Board and re-appointment of Fay Sweeney to the Library Board. Motion carried.

DECLARATION OF INDEPENDENCE: Mayor Bloem noted that it was her honor to represent the City at the Declaration of Independence road tour stop in Coeur d'Alene this past week.

EXECUTIVE TEAM REPORT: Executive Team Leader, Mike Gridley, reported that a one- mile bike path was completed today on the west side of Atlas Road extending from Kathleen south to Appaloosa Avenue. The Municipal Services Department hosted an Election Workshop Thursday. Susan Weathers, City Clerk thanked the nine citizens who attended the workshop and also gave a special thanks to Councilman McEvers who provided an entertaining view of what is really involved in being a City Council person. For anyone who is interested in being a candidate for the City's Upcoming Election, candidate's packets are now available in the City Clerk's Office. The first day that the declaration and petition of candidacy can be filed with the City Clerk is September 12th and the last day is September 26th. If anyone has questions, please feel free to contact Susan Weathers, City Clerk at 769-2231. There will be a Budget Workshop in Council

Chambers starting at 5:30 p.m. on August 21st. This meeting will be to review the proposed budget.
