Across the country the U.S Department of Housing and Urban Development (HUD) funds local homeless assistance and prevention networks called Continuums of Care (CoCs). In addition to organizing, delivering and reporting on housing and services for people who are experiencing homelessness, CoCs are required to complete a one-night Point-In-Time (PIT) count at least once every two years during the last ten days in January. Data from the one-night PIT count and the longitudinal data collected by the Homeless Management Information System (HMIS) are the primary sources used to measure the progress in meeting the national strategic goal of preventing and ending homelessness.

Since 2005 Idaho has conducted an annual Point-in-Time Count of the homeless in the state. The data from this count helps determine the amount of funding awarded for Idaho's homeless programs, as well as to help understand the changes in trends among the homeless populations and raise public awareness of homelessness.

For the PIT count, CoCs are instructed to count all adults, children in households, and unaccompanied youth who meet HUD's definition of homelessness. At the time of the count a person is considered homeless only when he/she resides in one of the places described below at the time of the count:

- Unsheltered homeless person resides in a place not meant for human habitation. Included in this count are people in <u>temporary</u> tents or armory shelters, encampments, and warming centers.
- A sheltered homeless person resides in an emergency shelter, transitional housing or supportive housing for homeless persons who originally came for the streets or emergency shelters.

This definition of homelessness does not include persons who may be staying with friends or relatives, in a hotel/motel, in a treatment facility or in jail. Persons in these circumstances are defined as "Precariously Housed" and are often characterized as being at imminent risk of becoming homeless.

The following report is the result of Idaho's statewide Point-in-Time Count for the night of January 26, 2011.

- 2199 sheltered and unsheltered individuals and persons in households counted as homeless
- 1310 single individuals or members of adult only households
- 297 Households of two or more persons consisting of at least one adult and one child (889 total persons in households)
- Of persons who identified gender, 58% male and 39% female
- Of persons who identified age, 25% are under the age of 18
- Of persons who identified a Disabling Condition, 24% suffer from substance abuse and 17% from Mental Illness
- Of persons who identified, 15% are Veterans and 23% are victims of Domestic Violence
- In addition, 836 Precariously Housed individuals and households were surveyed during the unsheltered portion of the count, and although not included in the official PIT count numbers the survey responses are included in a separate form at the end of this report.

The PIT count consists of two methods to collect data for the night of Wednesday, January 26, 2011. The sheltered homeless data is collected from surveys filled out by the shelters and from the Idaho HMIS database. The unsheltered homeless survey is administered by "street or known locations" and "service based" counts conducted in each region in the state and entered into HMIS.








Total Sheltered and Unsheltered
