

MINUTES OF THE REGULARLY ADJOURNED MEETING OF THE CITY COUNCIL HELD
SEPTEMBER 23, 1946 AT 7:00 P.M. IN THE COUNCIL CHAMBERS AT THE CITY HALL

The Meeting was called to Order by the Mayor.

ROLL CALL The following councilmen answered to the roll call, Pierce, McDonald, Sonnichsen, Frandsen, Hurrell, Fender.

At this time the Mayor announced the appointment of a safety committee as follows, chairman, councilman Fred S. Merrill, members councilmen Pierce and Sonnichsen.

At this time the council took up the consideration of the zoning ordinance.

ORDINANCE NO. 843 ORDINANCE NO. 843 AN ORDINANCE REGULATING AND RESTRICTING THE LOCATION AND USE OF BUILDINGS AND THE USE OF LAND WITHIN THE CITY OF COEUR D'ALENE, LIMITING THE SIZE AND AREA OF BUILDINGS; PRESCRIBING YARDS AND OTHER OPEN SPACES; REQUIRING THAT OFF STREET PARKING SPACE BE PROVIDED FOR MULTI-FAMILY DWELLINGS; FOR THESE PURPOSES DIVIDING THE CITY INTO DISTRICTS AND PROVIDING FOR THE ENFORCEMENT OF THIS ORDINANCE AND FIXING PENALTIES FOR VIOLATION OF ITS PROVISIONS.

Ordinance NO. 843 was read the first time by the clerk in its entirety and it was moved by McDonald seconded by Fender that Ordinance NO. 843 pass its first reading, and upon roll call vote all councilmen voted in the affirmative except Field and Merrill, absent and not voting.

It was then moved by Pierce seconded by Sonnichsen that the rules requiring an ordinance to be read on three different occasions be suspended and that ordinance NO. 843 pass its second and third readings by title only.

Thereupon Ordinance NO. 843 was read the second time by the clerk by title only and it was moved by Hurrell seconded by McDonald that ordinance NO. 843 pass its second reading and upon roll call vote all councilmen voted in the affirmative except Field and Merrill, absent not voting.

Thereupon Ordinance NO. 843 was read the third time by the clerk by title only and it was moved by Sonnichsen seconded by Fender that Ordinance NO. 843 pass its third reading and upon roll call vote all councilmen voted in the affirmative except Field and Merrill, absent not voting.

It was then moved by Fender seconded by McDonald that Ordinance NO. 843 be declared an duly enacted ordinance of the City of Coeur d'Alene and upon roll call vote all councilmen voted in the affirmative except Field and Merrill, absent not voting, Mayor Rosenlund then declared Ordinance NO. 843 to be an duly enacted Ordinance of the City of Coeur d'Alene,.

LETTER OF THANKS TO ZONING COMMISSION At this time it was moved by Fender seconded by Pierce and carried that the Mayor and Council express their appreciation to the zoning commission for the time and effort they have spent drawing up the zoning ordinance, by a letter of thanks from the Mayor and councilmen.

BUILDING INSPECTOR For the purpose of enforcement of the provisions of Ordinance NO. 843, it was moved by Pierce seconded by Hurrell and carried on roll vote that the city surveyor, Bert McTighe be appointed building inspector of the city, and all permits for building shall be approved by the building inspector befor being issued.

There being no further business the meeting was adjourned.
