The Program

The City of Coeur d'Alene has instituted an Emergency/Minor Home Repair program to help low to moderate income homeowners correct building conditions that threaten the health and safety, or the soundness of their home. The program will provide grants, up to \$5,000 for emergency repair, accessibility improvements, and other minor repairs. Cosmetic requests will not be considered, including air conditioners.

Eligible Work:

- Repair electrical, plumbing, or heating system
- Repair leaking roof
- Install ramps, grab bars/lever hardware
- Create accessible pathways, including sidewalk repair/ replacement
- Emergency Sewer/Water Repairs, Code Enforcement

PROGRAM DETAILS

Grants will be provided on a first come first serve basis

Process:

- Once homeowner has established basic eligibility, a full application must be submitted to Panhandle Area Council for the City's preliminary approval.
- The homeowner is responsible to obtain bid/quotes for work to be accomplished through the program. Final approval will be based on homeowner submittal of bids/quotes.
- Final approval must be given prior to start of any construction.

Construction:

Inspections (by the City and/or their agents) will be required before, during, and after construction.

Eligibility:

- Owner must occupy the home
- The home must be within Coeur d'Alene's city limits
- Household income can not exceed the HUD established LMI income limits.
