PUBLIC HEARING - L.I.D. 146 - IMPROVEMENTS TO NORTHWEST BOULEVARD: Mayor Bloem read the rules of order for this public hearing. Dick Suchocki, Project Manager, gave the staff report. Mr. Suchocki reviewed the improvements made with this project. The total project cost was

\$5.4 million. State and City funding that was in place was approximately \$4.5 million with the L.I.D. costs at \$835,000.00. Improvements included sidewalks, curbs, street improvements, median landscaping and driveway approaches.

WRITTEN COMMENTS: Written comments from Jeffrey Child, attorney for Eleanor Smith and Donald and Robert Johnston and from John Stone were distributed for Council review.

PUBLIC COMMENTS: Jeff Child, 212 S. 11th Street, representing Eleanor Smith and

Donald and Robert Johnston, stated that he feels the property that his clients lease really belongs to the City and not the railroad and feels that there has not been adequate research done on this subject. Also, his clients' property had two driveway entrances and after the

improvements still had two driveway entrances. Mike Ormsby, Bond Counsel for the City, responded that I.C. 15-1701 tells the City how to complete assessment rolls which requires the City to obtain a list of property owners from the County Assessor's Office, which is what

the City did. The property owner is listed as the railroad and it is the railroad that is being assessed these improvements. Willliam Sheldon, 1620 NW Blvd. said that he has never received a notice except for the last assessment roll notice. He feels that city staff are not doing their job in the city since the staff did not send out these notices by certified mail.
