They will also have donuts and coffee/juice to all the attendees. The city will be giving away seedlings as well as a couple of larger

scale trees. Nick asked that anyone that can attend please does as he is hoping to have leaders for every group of kids at each tree. JD reeves mentioned that NIC is holding its seedling give away on Saturday 04/29 and will be pushing off the NIC "big' Arbor Day celebration for next year and will be working with New Leaf Nursery on that.

5) URBAN FORESTRY PROJECT IDEAS:

Nick said that he has been very focused on Arbor Day but plans on getting the fencing done around the American Chestnut trees this year and plans to do so before the winter. Nick also said that a new property owner has purchased the US Bank property against Seltice and will be installing trail at this site. This will give the opportunity to expand the trailside Arboretum.

6.) INSPECTION REQUESTS:

- 801 E Gilbert: removal request of two (2) Ponderosa pine trees. One (1) approved for removal due to utility conflict. One denied and tree required to be retained.
- 1016 E. Pennsylvania Ave: removal request one (1) horse chestnut tree. Removal approved due to its condition and spacing issues.
- 3606 Loxton loop: removal request one (1) Pear tree. Tree removal approved due to severe surface rooting issue with limited mitigation options.
