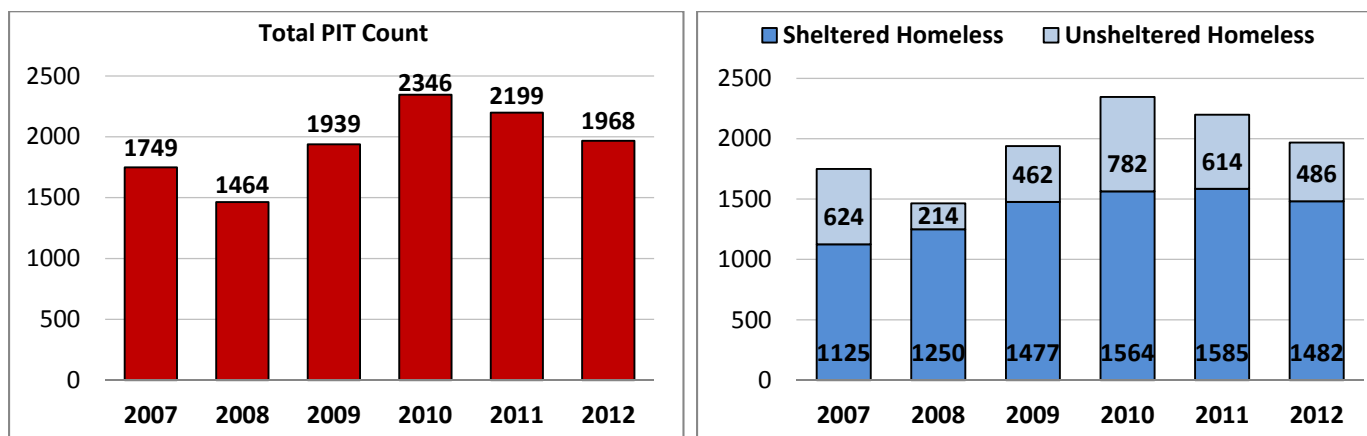


State of Idaho January 2012 Region One Point-in-Time Count Report

The U.S Department of Housing and Urban Development (HUD) funds local homeless assistance and prevention networks called Continuums of Care (CoCs). In addition to organizing, delivering and reporting on housing and services for people who are experiencing homelessness, CoCs are required to complete a one-night Point-In-Time (PIT) count of all homeless persons at least once every two years during the last ten days in January.

On January 25, 2012 Idaho's two Continuums of Care conducted the 8th annual statewide PIT Count. The data from this count helps determine the amount of funding awarded for homeless programs across the state, as well as to help understand the changes in trends among the homeless populations and raise public awareness of homelessness. Data from the one-night PIT count and the longitudinal data collected by the Homeless Management Information System (HMIS) are the primary sources used to measure the progress in meeting the national strategic goal of preventing and ending homelessness.

State of Idaho PIT Snapshot - All Regions



- Of persons who identified in 2012: 40% are in households with children; 25% are under the age of 18; 58% are male and 39% female; 18% are veterans; 22% are victims of domestic violence; 13% are chronically homeless; 25% suffer from substance abuse; and 17% from mental illness.

For the PIT count CoCs are instructed to count all adults, children in households, and unaccompanied youth who, on the night of the count, resides in one of the places described below:

- An unsheltered homeless person resides in a place not meant for human habitation. Included in this count are people in temporary tents or armory shelters, encampments, and warming centers.
- A sheltered homeless person resides in an emergency shelter, transitional housing or supportive housing for homeless persons who originally came for the streets or emergency shelters.

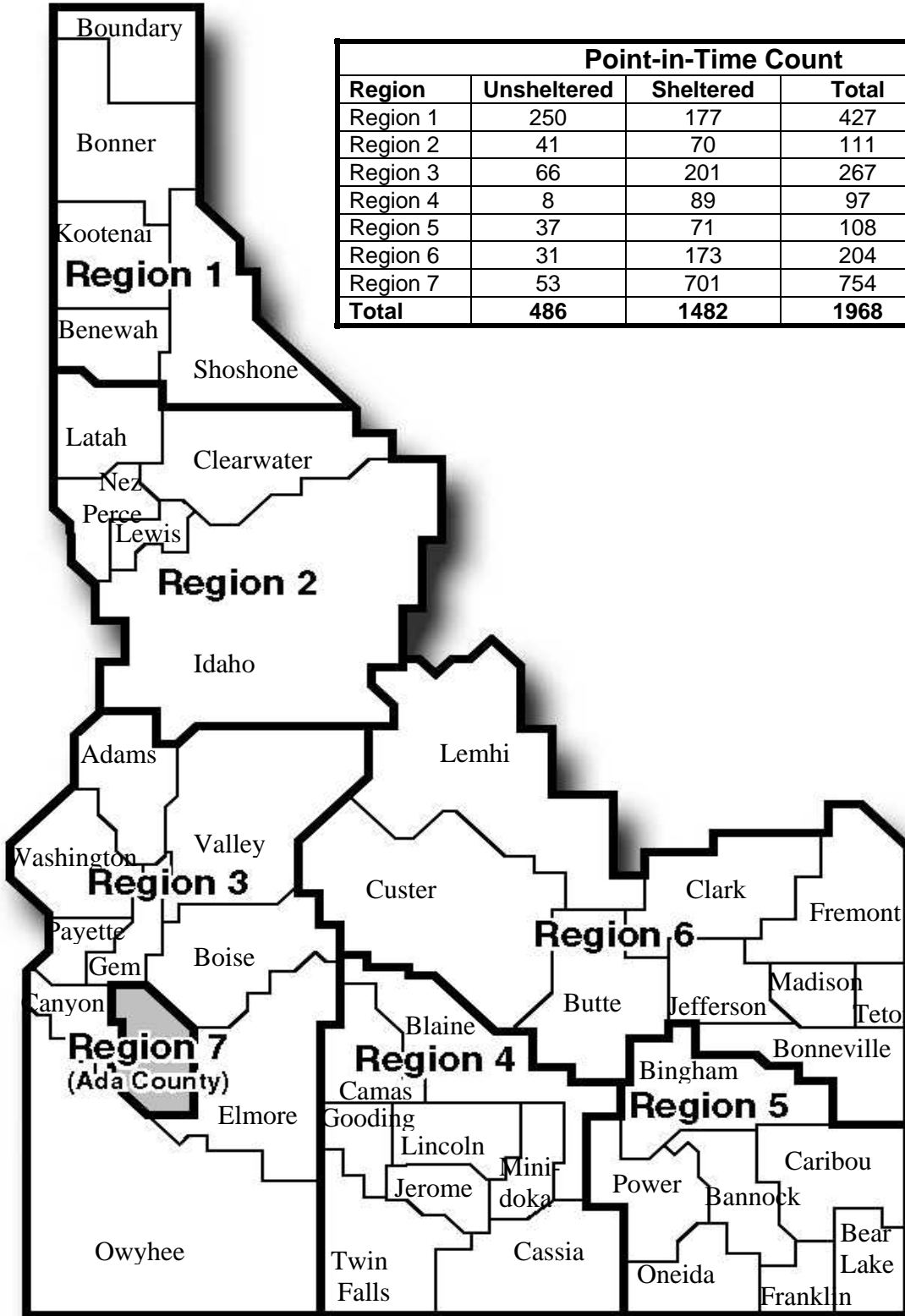
The PIT count's definition of homelessness does not include persons who may be staying with friends or relatives, in a hotel/motel, in a treatment facility or in jail. Persons in these circumstances are defined as precariously housed and are often characterized as being at imminent risk of becoming homeless. A total of 543 "precariously housed" individuals and households were surveyed during the unsheltered portion of the count and, although not included in the official PIT count numbers, the survey responses are included at the end of this report.

The PIT count consists of two methods to collect data. The sheltered homeless data is collected from surveys filled out by the shelters and from the Idaho HMIS database. The unsheltered homeless survey is administered by "street or known locations" and "service based" counts conducted in each region in the state and entered into HMIS.

Sheltered information as reported on provider survey form. Unsheltered information as reported on regional survey form. Not all surveys had responses, blank values not reported.

A Chronically Homeless Person is defined by HUD as:

- An unaccompanied homeless individual with a disabling condition, or a family with at least one adult member who has a disabling condition, who has either been continuously homeless for a year or more OR has had at least four episodes of homelessness in the past three years.
- AND
- The homeless person must have been sleeping in a place not meant for human habitation (e.g. living on the streets) and/or in emergency shelter at the time of the count.
